## Private lessons info

1. Booklet hours are valid until December 31, 2018.
2. Booklet hours are non transferable from a person to another.
3. Ski tickets are not included in private lessons rates.

## Cancellation policies initials

4. It is the customer's responsibility to contact the Snow School before 8:00 a.m. on the morning of the lesson to postpone a private or semi-private lesson. No credit or lesson re-take will be made if the Snow School was not notified before 8:00 a.m. The lesson will automatically be lost.
5. No refund request will be accepted on private lessons. In the case of a cancellation request (done before 8:00 a.m. on the morning of the lesson), the lesson will be postponed to a future date or a Mont SUTTON credit may be issued. If the booklet hours are initiated, the credit calculation will take into consideration the unit price of each lesson used. In case of an injury, the initiated lesson booklet will be extended to the next season if medical documentation is provided.

## Acknowledgement and acceptance of risks
