



User agreement - chalet, shelters and rustic campsites Alt. 840 m

ARRIVAL AND DEPARTURE TIME

You can arrive from 12 noon or later and we ask you to leave by 11 a.m. at the latest. There is no welcome desk at the foot of the mountain. The sites are only accessible by foot. Plan about 1:30 of uphill walking distance from the main chalet (alt. 400 m) and about one hour of uphill walking distance from Parc d'environnement naturel de Sutton's reception (alt. 520 m) to reach the campsites, shelters and dormitories which are located at the summit (alt. 840 m).

ACCESS TO THE CHALET AT THE SUMMIT

All campers have access to the chalet's installations, during its opening hours, when the guardian is there. The chalet is open according to this schedule (and sometimes even for longer periods of time):

Friday: 4 p.m. to 11 p.m. **Saturday:** 7 a.m. to 11 a.m. and 4 p.m. to 11 p.m.

Sunday: 7 a.m. to 11 a.m. and 4 p.m. to 11 p.m.

Thank you for not leaving anything you might need in the chalet during the closed periods. Each camper have the responsibility to pick up their personal effects (including trash) when they leave. For those using the kitchen in the chalet, this includes doing your dishes and cleaning the counters.

POLICY ON MINORS

Minors (under 18 years old) have to be under the supervision of at least one responsible adult.

CURFEW

A curfew is in place from **11 p.m.** Thank you for respecting other camper's right to tranquility.

GARBAGE

We recycle and compost! There is a recycling and garbage bin in the chalet and in each restroom, and a compost bin in the chalet. Thanks for helping us reduce the odors and the transport of the garbage by ecologically disposing of it.

WATER

Tap water is not **drinkable**. Drinkable water is carried up each week by chairlift. It is accessible to all in containers stored at the entrance of the chalet. Thank you for not wasting any of it, it is limited and it requires efforts to bring it to the summit. Note that there are no showers but some ecological dry toilets are accessible.

CAMPFIRE & WOOD FIRE (free & shared access)

There is a fireplace in the chalet and two designated campfire sites outside. For security reasons, it is **strictly prohibited to start a fire elsewhere**. The guardian is responsible for the wood stock. He respects the [SOPFEU](#) grade. Take a look on the [SOPFEU](#)'s intensity map before your visit.

ANIMALS

On-leash **dogs** are allowed on campsites and in shelters. However, out of respect for users of the chalet, we ask you not to enter it with your dog.

Thank you for not feeding wild animals, for their well-being and your safety!
